The Law Enforcement Portal ("Portal") is **only** for use by a law enforcement agent/officer ("LEA") who is (a) conducting a verifiable investigation pursuant to which (b) the LEA's agency would otherwise need to serve legal process (e.g., subpoena, warrant, court order, or summons) to Inteliquent/ Sinch Voice to (c) obtain **customer identifying information** about a target number identified by the LEA ("Legal Demand") as being **currently in-service** with Onvoy, LLC, Inteliquent, Inc., and/or their affiliates ("Company"). The above LEA applicant ("Applicant") agrees to **only** submit queries for numbers that would otherwise constitute a valid Legal Demand and understands that we reserve the right to audit queries submitted via the Applicant's Portal profile and we may request written verification from the Applicant's supervising agent/officer concerning same.

Applicant acknowledges and agrees that Company may establish **query volume/interval limitations and other conditions** for Portal use, and that the same are subject to change by Company (for which notice will be directed to the email above). Such present limitations and conditions include: (1) queried numbers only return results for numbers in-service on the **query submission date** and for which we have the proactive CPNI consent of the present customer (results will specify the in-service date for that customer for that number -- LEAs seeking other historical information must submit legal process to LEArequests@sinch.com – see next paragraph); and (2) daily limitation of 25 queried numbers per user.

Applicant acknowledges and agrees that the result of a Portal query submission will generally be either: (1) the identity of our **current** wholesale customer for the target number and their contact information (i.e., where the number is in-service for a customer who has proactively consented for CPNI purposes to the inclusion of their numbers into the Portal database); or (2) informing the LEA of the need to instead submit legal process valid in the LEA's jurisdiction for the information sought (i.e., the target number is one for which our customer has **not** proactively consented for CPNI purposes or the number is not presently in-service). **Where legal process is necessary**, submit the same only via email to LEArequests@sinch.com, along with a completed Cover Page Form, and consistent with our then-current Law Enforcement Agency Support Guidelines (please specifically review section 4.1 - "Necessary Details"). Applicant acknowledges and agrees that Portal access credentials are established on a LEA-specific basis and **must not be shared or negligently allowed to be used** by others. Portal access and use inconsistent with this application (including, but not limited to use by other persons) will result in termination of Applicant's profile without prior notice, and may further result in termination of profiles for **all other LEAs with the same agency**. Company may decline to establish further profiles for any such agency.

Applicant acknowledges and agrees that Portal access passwords established pursuant to this application **will periodically expire**, and it will be the Applicant's responsibility to monitor the above-provided email address for communications from Company. Disuse of an established password and failure to timely update the same following its expiration may result in notice from us and thereafter, termination of the profile and the need to submit a new application. Applicant further agrees that it is the Applicant's responsibility to maintain current contact information with Company and remain as an LEA in good standing with the above-identified agency at all times of Portal access and use. Where the Applicant ceases serving on an active duty, good standing basis with the agency, Applicant and agency **must promptly notify** Company to terminate the Applicant's Portal profile. Notwithstanding the foregoing, Company will immediately terminate a profile without prior notice upon discovering Applicant's status inconsistent with the foregoing, and may further terminate profiles for all other LEAs with the Applicant's agency. Company may decline to establish further profiles for any agency for which profiles are so terminated.
