1-Way SMS Services

Sinch Global

Scope: This is Sinch standard, Global SMS offering which enables extensive access to all Sinch's covered destinations via a single connection. This is a one-way messaging offer and routing is optimized to make sure that as many features as possible are supported, such as keeping the sender ID intact wherever possible. Some destinations will require preregistration of sender ID to deliver intact or even at all. With specific countries or operators, specific senders are not allowed.

Routing is optimized to facilitate delivery to ported and roaming subscribers, neither of these can be guaranteed, but with the use of an extensive network of direct connections this provides the best possible chance for traffic to deliver.

Sinch Select

Scope: This is Sinch coverage using our direct connections only. These are SS7 interworking or direct SMSC integrations used as on-net directs or local off-net. The exact type of connection used is described in the feature comments of the coverage list.

This is a one-way messaging offer and is aimed at enterprises that perform intelligent routing and number portability in-house, such as other resellers of connectivity. Specific feature information and potential requirements of preregistration are mentioned in the feature comments of the coverage list.

2FA

Scope: Caters to traffic related to Two Factor Authentication (2FA) which main aim is to be used for verification codes, 2FA and One-time Pin code type content for verifications. This is a one-way messaging offer and routing is optimized to keep latency of delivery as low as possible with intact content. Extra features such as keeping the sender ID intact where possible may not be supported. Some destinations will require preregistration of sender ID to deliver messages.

Marketing

Scope: This is a more cost-efficient alternative to our standard routing. Specific SMS features are not guaranteed as they are likely to be replaced/overwritten to offer more competitive pricing.

This is a one-way messaging offer and routing is optimized to strive for cost- competitiveness through a reduction of supported SMS features. Instead of supporting all "corner cases" like we always aim to do in our Global routing (GWO), we will reduce feature support to reduce cost.

MT Service Name: Marketing

Local

Scope: One specific gateway for clients to deliver traffic related to local brands to numerous destinations in the world where this local traffic differentiation is available.

This is a one-way messaging offer and made available as a means to deliver traffic related to local brands in named countries that are charged at a low rate. Most destinations covered by this service will require preregistration of sender ID or similar to deliver messages properly. Only applies to approved local brands defined per destination and the categorization is subject to change over time.

OTT

Scope: Caters to traffic like verification codes and One-time Pin code type content for verifications or clean transactional traffic. This is a more cost-efficient alternative to our standard routing on Sinch Global or Sinch 2FA. Specific SMS features such as intact originators are not guaranteed as they are likely to be replaced/overwritten to offer more competitive pricing.

This is a one-way messaging offer and routing is optimized to strive for cost- competitiveness through a reduction of supported SMS features. Instead of supporting all use cases like we always aim to do in our 2FA or Global routing (GWO), we will reduce feature support to reduce cost and allow only certain business cases to use this product.

Scope: Sinch offers domestic gateways that are provided as one-way messaging offers and routing is optimized for specific use cases in the specific destination country. Connectivity is only for the destination country of each gateway. The client has full responsibility to ensure messages sent through the Sinch platform are compliant with local laws and regulations.

In China it's not allowed to send religious content, sexual content, gambling, loans, property SMS etc. Marketing is only allowed if the subscriber has opted in.

MT Campaigns using the long numbers as sender ID are not allowed and may lead to service suspension. A ratio of at least one MO per MT is required. Any deviation from this ratio may trigger a service suspension.

These numbers can be used for communication between mobile subscribers and a technical platform. There must be an MT in reply to every MO.

This long number range is OK for use cases that call for the collection of responses back from end users, e.g. doctor appointments/parcel rescheduling messages; in both cases end users are offered with the option of replying to the content provider.

This long number range shouldn't be use for MT only use cases where end users are not expected to reply, e.g. OTP or pure reminders/alerts.

This long number range shouldn't be used for MO only use cases, as an MT is expected in reply to every MO.

This is a service tailored to clients that need to test Sinch's platform resilience or platform-to-platform capacity during a limited time. No SMS messages are sent out from Sinch's platform via this service, instead it's geared to produce a failed or positive delivery report.

Service Specific implementation:

- Traffic to specific ranges starting with 440000000 and 467070 will return a failed Delivery Report with error code 300
- Traffic to all other numbers and ranges starting with 1-9 returns a positive Delivery Report

This is by implementation a one-way messaging offer, but no outbound SMS is ever generated from Sinch's platform on this service.
